Thank, ou very much for your letter and please excuse me for delaying the reply.

Taye told me about your earlier message and that $^{\rm I}$ was to speak on my parent's case in public which $^{\rm I}$ avoid as much as possible. Your letter clarified this for me.

I will be glad to come to London. But I am very careful not to speak about my parents in public, since I aherkeye that this might have undesirable consequences for them, especially for my mother with whom I have some contacts. I hope, you know the nature of the Ethiopian government and that you share my fears.

I understand you were misinformed about this possiblity. I prefer to speak only to closed groups and institutions. If this is acceptable to you, I will be glad to come to London between 4th and 11th of December. I can not speak on public meetings and press conferences concerning the fate of my parents.

All your proposals would be all right for me and I will cooperate in all possible ways, except the point I have raised above. Therefore, if this is still alright let me know.

Again, I would like to thank you for the invitation. I look forward to both meeting you in person and hear from you.

It was good news to hear from Taher that you are willing to come here for a publicity tour.

We have discussed this with Amnesty International who are naturally most interested in your trip as both your parents are on their list of "Prisoners of Conscience".

You may know that the most important day in the year for Amnesty international is 10th December, which is both the day on which they publish their Annual Report and is also Human Rights Day internationally. We all felt, therefore, that if we could build your visit around that day, this would be the best time for you to come. There would be a Press Conference in the morning for AI during the course of which they would ask you to speak about your father in particular (as he is one of 16 people whose cases they are highlighting).

There is also an important meeting on "Disappearances" of the Parliamentary Group on Human Rights, which includes Members of both Houses of Parliament and all political parties, which will be held on 1st December. Again, your presence at this meeting would be extremely helpful.

I am not sure how long you can be away from Germany, so we have not fixed any details. We would like to propose, however, that you come on November 30th and stay here until 10th or 11th December, if that is convenient to you. If you can manage these dates we would suggest the following programme:

1st Parliamentary Group on Human Rights

2nd - 9th One or possibly two Regional meetings for

Amnesty International

Meeting at Africa Centre for Rights and Justice -Discussion with British Council of Churches

Discussion with aid agencies

10th December Amnesty International Press Conference_

We would also like to arrange for you to be interview by the BBC (who have said they would like this) and representatives from the church press and perhaps one of the major Sunday newspapers, like the <u>Observer</u>.

Please let us know whether these proposals would be all right for you. You would of course stay with Mohammed and he or I would take you to the various places for meetings etc. Of course your expenses would be paid.

Taher has told me that you would generally like to speak on the general situation in Ethiopia - and especially the Oromo question - rather than specifically on your father's case. Of course, people will want to hear about him, but we, too, are anxious that the whole question of repression and human rights in Ethiopia is important. We would hope therefore that you could speak on that subject at the Africa Centre and

Dear Kulani Gudina

I'm enclosing a copy of our Prisoner of Conscience Week publication, which features the case of your father's 'disappearance', in case you haven't received it from Amnesty workers in the Federal Republic of Germany. Your father will also be among the 'disappeared' to be featured in a special international campaign we are launching in December on the subject of 'disappearances' internationally.

I expect you have again been in contact with the UN Working Group on Disappearances; although they have had no positive response from the Ethiopian authorities, I assure you they work as hard as they can on the cases they take up. It was a great advantage in your father's case that they received a submission from a relative (yourself) in addition to Amnesty International - which the Ethiopian government continually attacks with possibly the greatest hostility of any government in the world.

I am writing too to ask you whether you have decided to involve yourself - and your brothers and sisters - in any public campaigning on your father's and mother's behalf. Previously I think we were in agreement that this could have undesirable consequences for your parents, but I wonder what your view is now. I hesitated to approach you about this, until being informed - rightly or wrongly, I'm not sure - that you had already spoken in public in Germany about your father's 'disappearance', and that you might be visiting the United Kingdom shortly for the same purpose. I don't know under what auspices this might have been done, presumably via the Lutheran Church rather than Amnesty International. I have recently in fact been approached by two film-makers, whose films would be shown on television in Belgium and Norway respectively, asking for contact to any relative of any of the 'disappeared' in Ethiopia who would be willing to speak on film. If you wish to be associated with this, or with any public campaigning, either by Amnesty International or the churches, I'd be glad to know.

Our last information about your mother, Tsehai Tolessa, was that she had been moved to the Menelik Palace. Is this correct? I spoke recently with a lady from the Methodist Church here who had spoken to an Ethiopian priest (not EEMYC, but some church with Swedish contacts) who visited a prisoner

in the cell next to your mother and saw your mother. I couldn't find out any more details, nor even the name of the prison, but your mother was said to be all right and possibly receiving visits or food. We have no new information about your father. Confidentially, the Ethiopian representative informed the UN Commission on Human Rights in April 1981 that your father had been reported as having been taken away by the OLF, and being in OLFheld territory, which is not credible at all.

I have not heard of any of the 1980 Oromo political detainees being among the prisoners released in the amnesty last month. Do you have any further information about this? I am very sorry the amnesty did not include your mother - let us still keep on hoping.

The Norwegian Missionary Society is to publish a book on African church leaders, and I have the honour to be asked to write about Qes Gudina Tumsa. I loved him and count myself a friend and co-worker of his. Therefore I am happy to be entrusted with the task to write about him.

Although I new Qes Gudina quite well through many years, I am sorry I did not gather more exact datas about him. Can you help me? - When was he born (in 1929?)? What are the names and the work of his parents? What about the conditions of his Childhood? Some features would be fine, - even also from his mature life. Important facts about his education and important jobs, family and family life would be of great interest. A daughter's (your) appreciation of her father would be most welcome.

You may have many facts to add, and they will all be of great help.

We still hope that Qes Gudina is alive, and we shall be very careful in our writing so that we don't hurt his case, but we want to honour him. If you can give me some information, I shall remember to handle them most carefully, and -if you so wish- don't mention you as my source. What is your opinion on this?

I like to add that you all, and especially your mother, are on our prayer list every morning. You shall continue to be there.

I hope I shall have the pleasure to hear from you. If you prefer to write in German or Amharic, I am able to read both.

Dear Father Bishop Lohse,

It is now over two years since we arrived here in Germany seeking refugee from the rigorous situation in the Empire state of Ethiopia.

Our father, Rev. Gudina Tumsa was unlawfully taken away on 28th July 1979

by special secret force of the military regime, while driving to his home exter a church service which he himself conducted. He was kidnapped on a special order from the chairman of the Revolution in Ethiopia, Mengistu Haile Mariam and his advisers. Since then nobody knows his wherabouts. In February 1980, our mother Tsehai Tolessa, was also arrested by the same force and was kept in that famous cell of the 3rd Police station of Addisabeba for nearly one year. She is now moved to the central prison where ther hundreds and thousands are kept without any trial.

During these years we waited for the churches, the christian communities and the world public to take up some means to approach the Ethiopian Military government demanding the information on whereabouts of our father and for the release of our mother. In particular we were expecting from the World Federation and the United Evangelical Churches of Germany direct help. We perienced during the last years a wide excercise of restrain towards the function of our parents.

On another and similar development in South Korea we observed very clearly how christians and you yourself have appealed to the Government of South Korea for the life and the release of Mr.Kim Dae Jung. In the case of our parents and many other similar cases in Ethiopia very little is done. Can you and the christians in this country appeal for the life of our parents to the Ethiopian Government?

We are at any time ready to express our concern personally wherever this may be necessary. We appeal to you and your church and to the churches of the World to do something towards the grave situation of our family particularly of our parents in Ethiopia. We have the wishes to hear from you or even to meet you at any time possible very soon.

Taking this opportunity, we would like to thank and all Christians who remeberd us through their prayers, and we thank also those friends who acceted us in their families and enabled us to continue our education.

We thank you and the others in your church who intend to do anything for the life of our parents.

Reverend audina Tumber, 52 years old, General Secretary of the Ethiopian Evangelical Church at 19 Mekane Yesus has was kidnapped on July 28, 1979 by unidentified gunner. He was forced by the four gunmen to get out of his car, which my mother was driving and into the case which was waiting for him. Please send carefully worded letters to the address given below, requesting the release of Tsehai Tolessa, clarification of the whereabouts of Gudina Tumsa and assurances of his physical safety if he is being detained. In your letters you should express your concern that a number of long-term political detainees "disappeared" around the same time as Gudina Tumsa. You should respectfully urge the Ethiopian authorities to provide a full account of the facts of these "disappearances" and state publicly what happened to the "disappeared" - whether they are alive in detention and, if so, where they are being held; or, if they are dead, what steps the government has taken to investigate the circumstances of their deaths.
